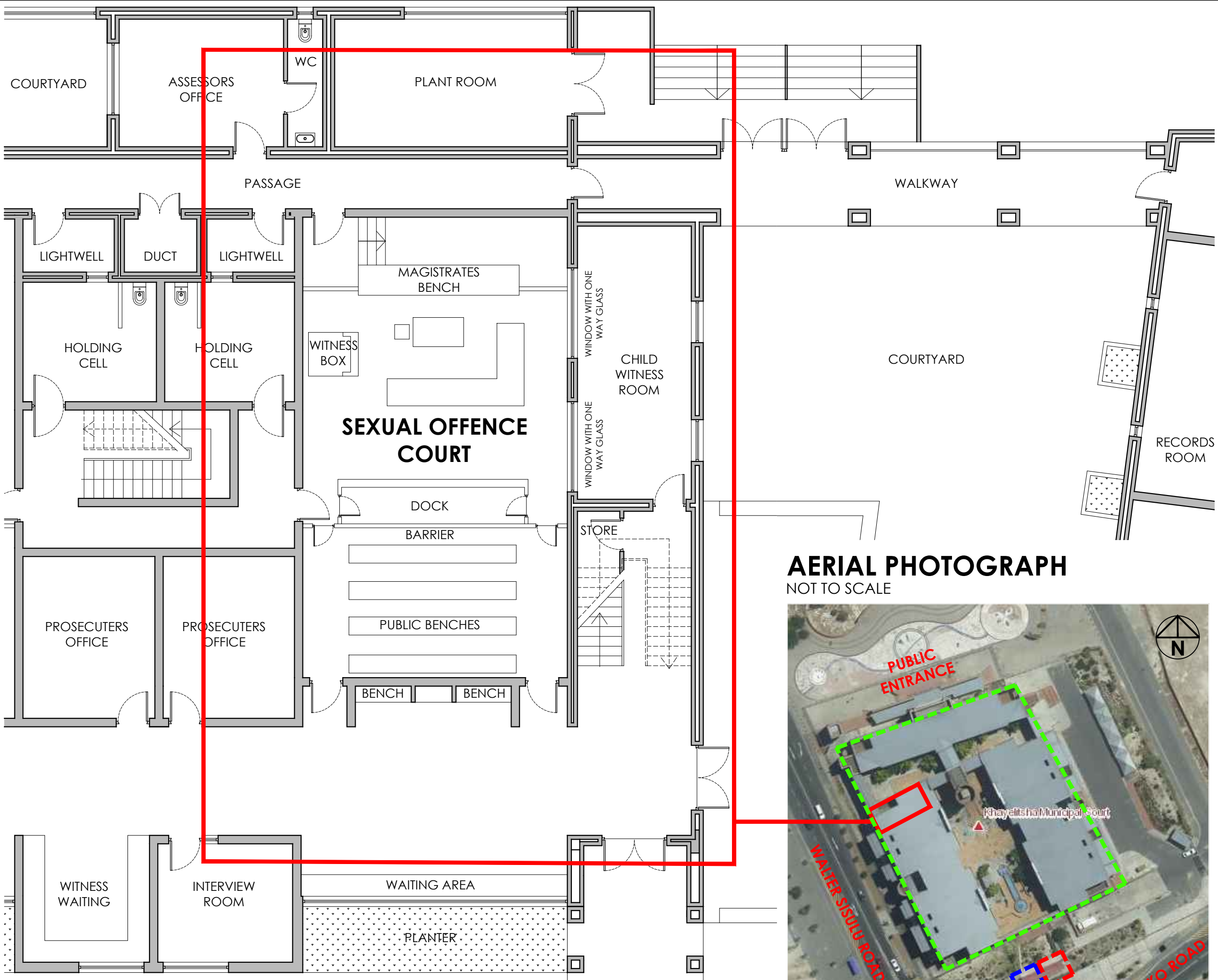

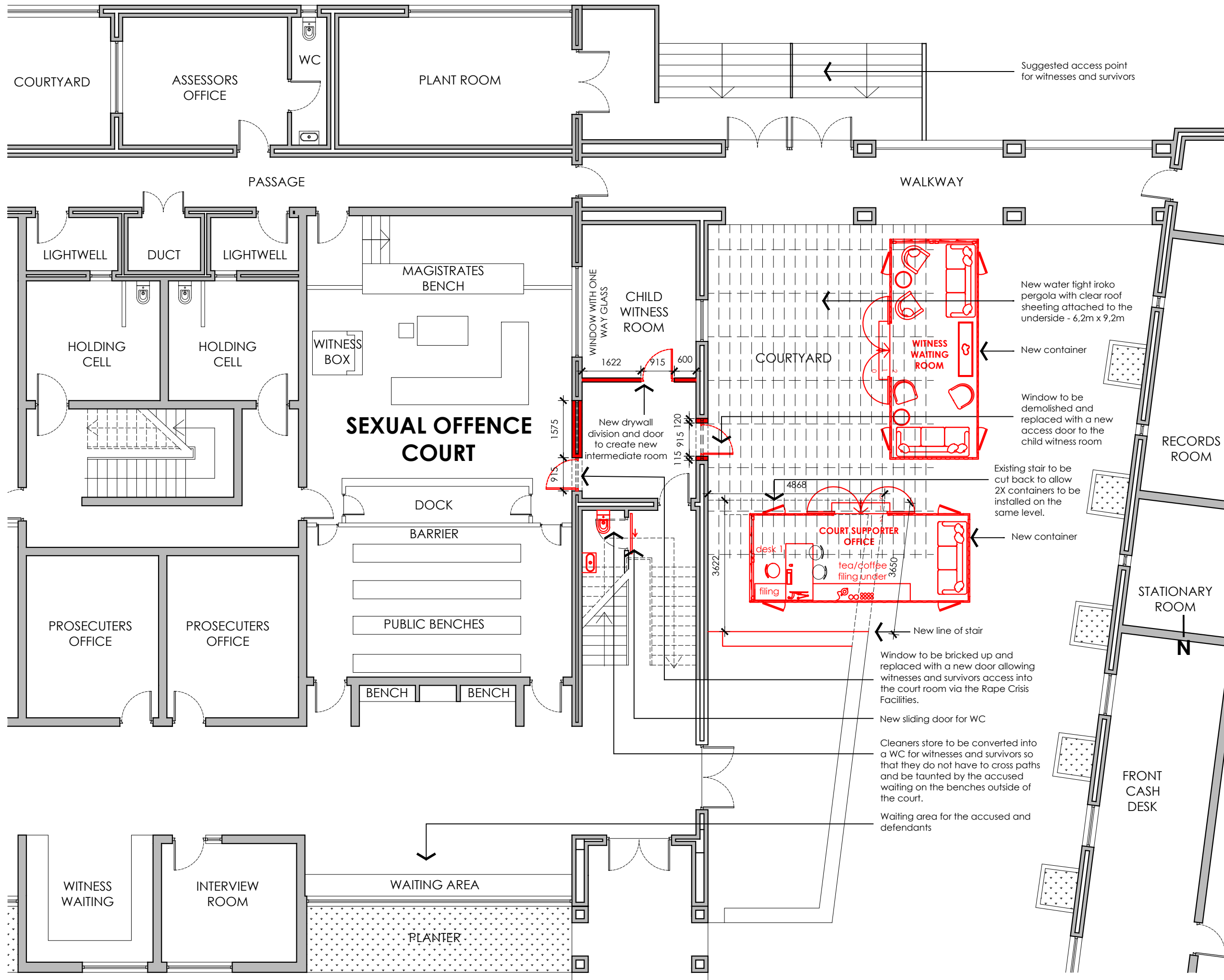


**EXISTING SEXUAL OFFENCE COURT: GF PLAN**

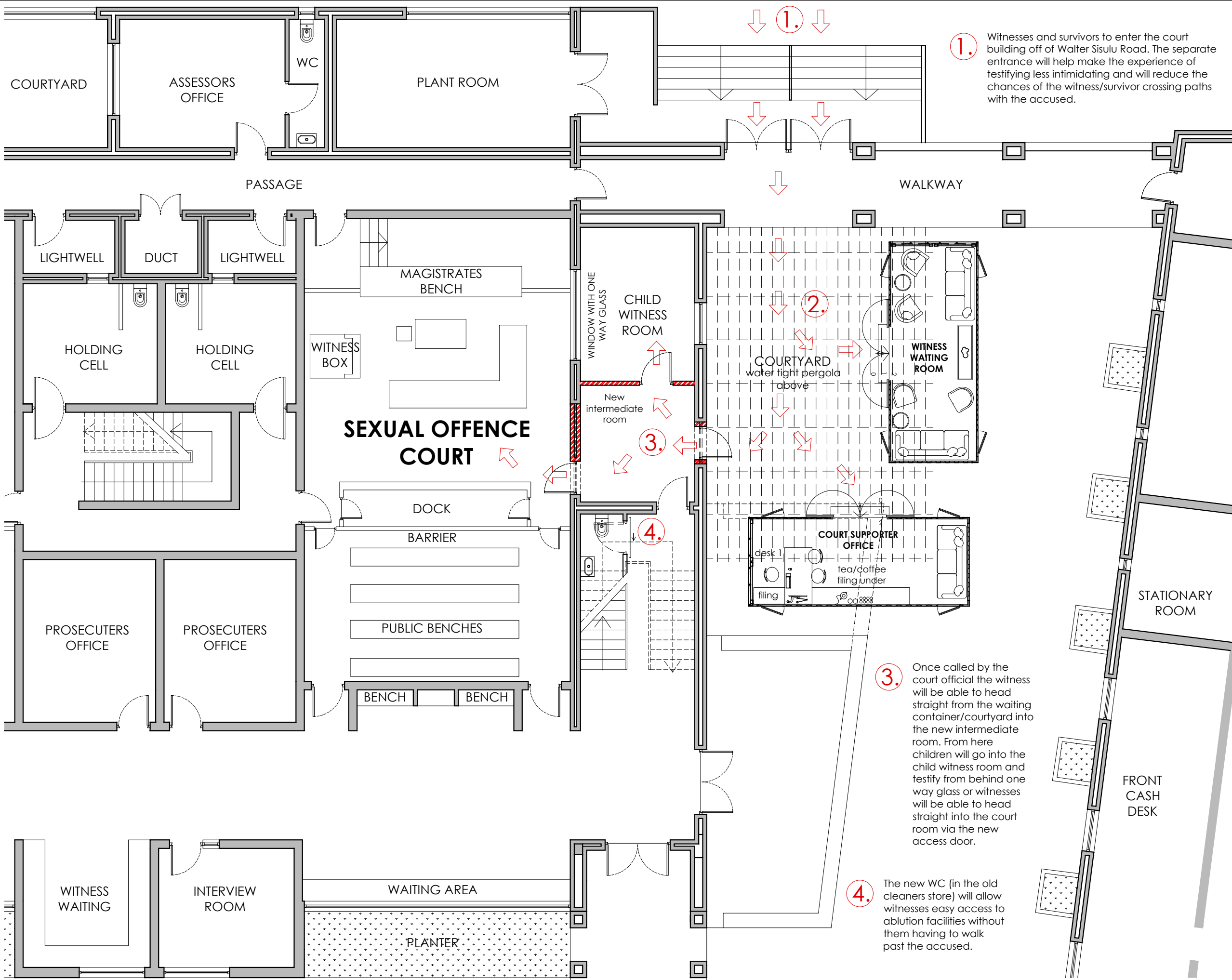

1. Witnesses and survivors to enter the court building off of Walter Sisulu Road. The separate entrance will help make the experience of testifying less intimidating and will reduce the chances of the witness/survivor crossing paths with the accused.

2. Once inside the court building the witnesses and survivors walk directly into the Rape Crisis Cape Town Trust's courtyard and then head to either the "Court Supporters" container or the "Waiting Room" container. The courtyards pergola will be water tight so that witnesses and survivors are protected from the rain. Currently they have to walk in the rain from the existing container.

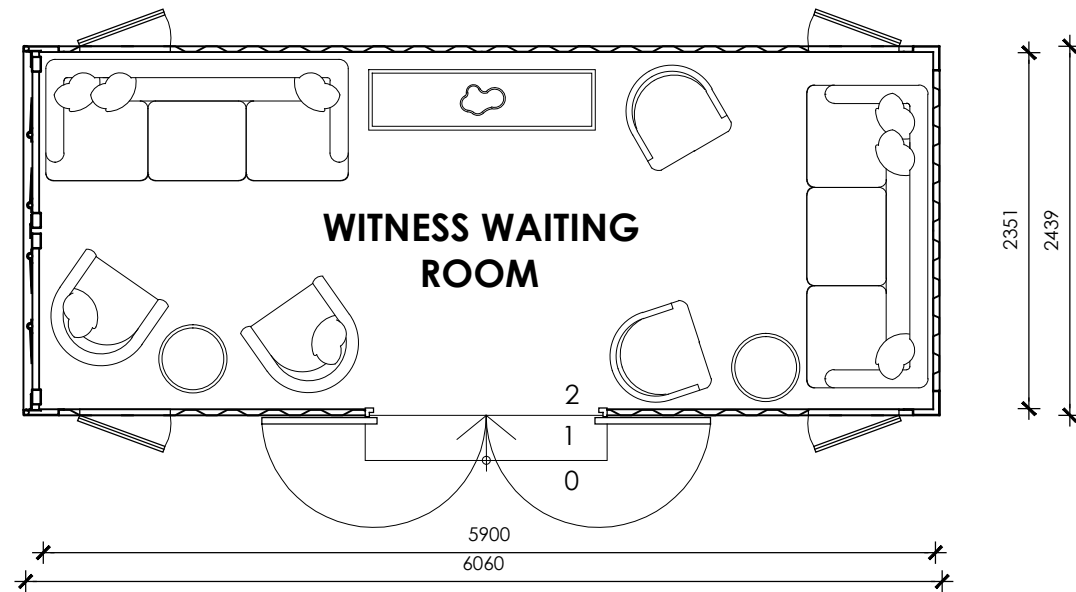
The covered pergola will also benefit the courts officials as they will no longer have to walk in the rain to call witnesses to testify.

3. Once called by the court official the witness will be able to head straight from the waiting container/courtyard into the new intermediate room. From here children will go into the child witness room and testify from behind one way glass or witnesses will be able to head straight into the court room via the new access door.

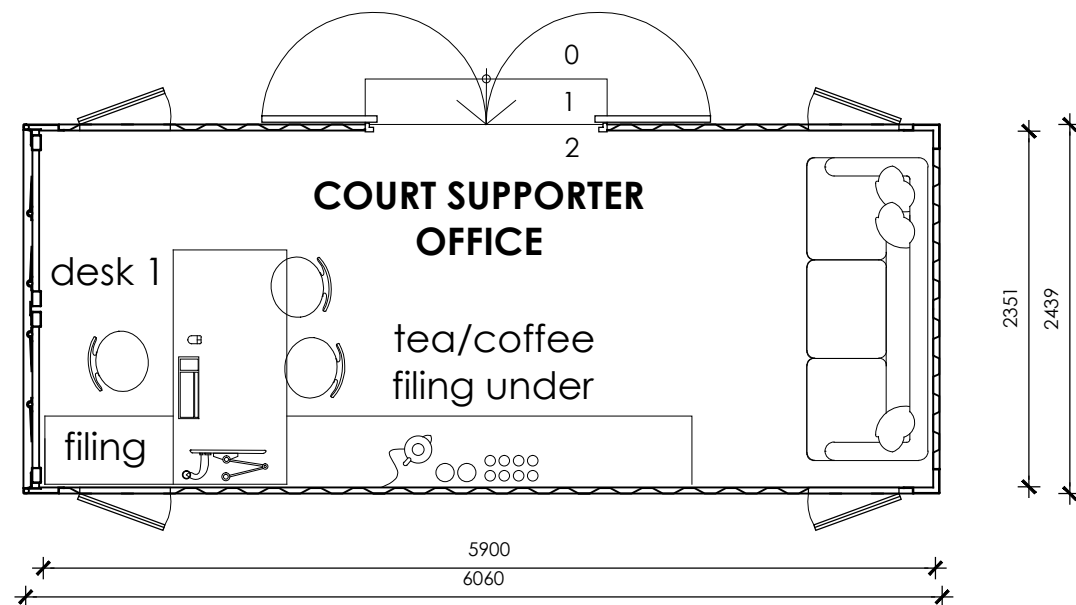
4. The new WC (in the old cleaners store) will allow witnesses easy access to ablution facilities without them having to walk past the accused.

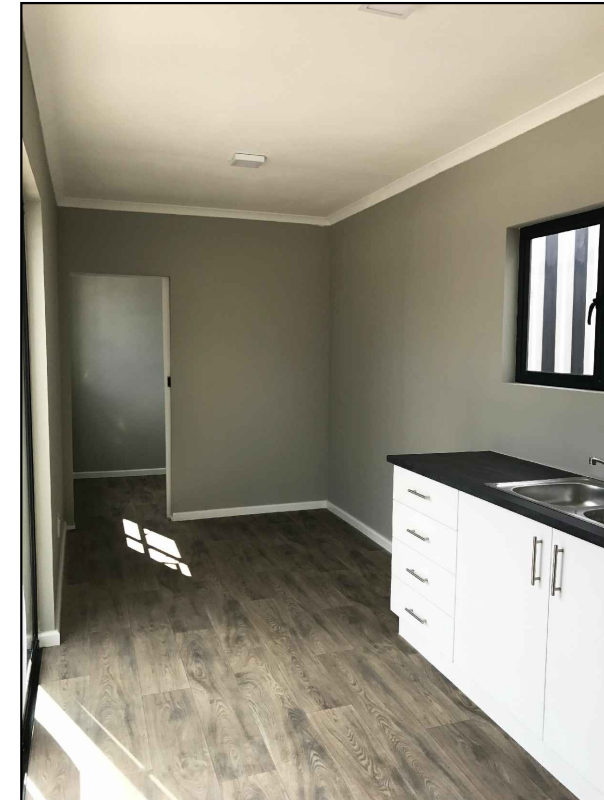
